## Statehouse Happenings

The General Assembly was pretty busy in April despite being on spring break for two weeks. With a five-week month, they were able to hold committee hearings during three.

The House Finance Committee ended hearing for the budget bill (HB 96), made all of their amendments and passed a substitute bill out of committee on April 8. The next day during a three-hour general session the House passed it. The vote was 60 to 39. Substitute House Bill 96 was sent over to the Senate the next day. The Senate began working on it when they returned from break.

During the month there were only four pieces of veteran/military legislation introduced. One bill and one resolution in the Senate and two new bills in the House. (see page six)

### March 1—April 4

Tuesday afternoon the House Education Committee had sponsor testimony for House Concurrent Resolution 7. It had been introduced by Representatives **Haraz N. Ghanbari** (HD-) and **Joseph A. Miller III** (HD-53) in February. The purpose of the resolution is to support and encourage the work of the American Legion Buckeye Boys State and the American Legion Auxiliary Buckeye Girls State in providing a premier educational and leadership program to the youth of Ohio. Both representatives offered testimony for their resolution.

The same day in the House Community Revitalization Committee sponsor testimony was given for House Bill 135 by Representative **Meredith R. Lawson-Rowe** (HD-5). Representative **Terrence Upchurch** (HD-20) who sponsored the bill with Lawson-Rowe was unable to be at the hearing. Their Bill would amend sections 4112.01 and 4112.02 of

the Revised Code to prohibit discrimination in rental housing based on lawful source of income. One of the sources listed in the bill is income from programs administered by the United States department of veterans' affairs or veterans' administration for any service-connected disability. The bill was introduced in February.

House Veterans and Military Development Committee members heard presentations from veteran organizations Wednesday morning. The first presentation was from William Hartman; Executive

#### April 7—11

The first hearing of the week was Tuesday in the House General Government Committee where sponsor testimony was given on two bills. Senators

**Michele Reynolds** (SD-3) and **Hearcel F. Craig** (SD-15) offered testimony on their bill AmSB 17. The bill was introduced in January and passed on the Senate floor with a 32 to 0 vote. It would enact section 5.212

designate October 4 as "Rutherford B. Hayes Day." It was introduced in January and in February it passed in the Senate 32-0 .

The House Veterans and Military Development Committee met Wednesday morning to hear testimony on SB 39 and HB 204. It was the first hearing in the house for both bills. Senate Bill 39 was introduced in January by Senators **Terry Johnson** (SD-14) and **Craig**. It had passed unanimously on the Senate floor in March. The bill would enact section 4113.13 of the Revised Code regarding the creation and display of a poster containing information on benefits and services for veterans.

Representatives **Erika White** (HD-41) and **Melanie Miller** (HD-67) offered testimony on their bill, HB 204. It would enact section 5.212 of the Revised Code to designate March 9th as "6888th Central Postal Directory Battalion Day." It was introduced in March as a companion bill to Senate Bill 17.

#### April 28—May 2

Following the Spring break there were plenty of committee meetings in both chambers. The House Veterans and Military Development Committee Chair, **Tracy Richardson** (HB-86) held the committee meeting at the National Museum of the U.S. Air Force on Monday. It consisted of a tour of the Wright-Patterson Air Force Base and presentations

from the 88th Air Base Wing of Wright-Patterson Air Force Base, 178th Wing of the Ohio Air National Guard, The Air Force Museum, and other community organizations.

The members learned more about the unit's organization, general mission and base priorities, as well as any challenges or issues that the legislature might be able to address. Speaker of the House **Matt**

**Huffman** (HD-78) also attended the meeting.

Tuesday morning the House Public Safety Committee heard proponent testimony for House Bill 1. The bill was introduced in January by Representatives **Angela N. King** (HD-84) and **Roy Klopfenstein** (HD-82) and would amend sections of the Revised Code to modify the law that prohibits certain governments, businesses, and individuals from acquiring certain real property. In February a companion bill was introduced in the Senate by Senator Johnson. There were four written testimonies received by the committee and they heard testimony from four witnesses in person. They were representatives of Ohio Farm Bureau Federation, State Armor, and American Legislative Exchange Council as well as Representative **Bernard Willis** (HD-74).

In the afternoon the House Workforce and Higher Education Committee heard testimony on HB 95. It was the first hearing for the bill that would make an appropriation to support higher education institutions that are members of the Ohio Veterans Education Council. The Committee heard testimony from the bill sponsors, Representatives **Andrea White** (HD-36) and **Brian Stewart** (HD-12).

Also, that afternoon the second hearing for SB 21 was held by the House General Government Committee. The only testimony was submitted by the Director of Government Relations at Ohio History Connection. SB 21 is the bill of Senators Brenner and Reineke that would designate October 4 as "Rutherford B. Hayes Day."

In the Senate General Government Committee that afternoon Senator Johnson's bill that would prohibit certain governments, businesses, and individuals from acquiring certain real property had a third hearing. The committee members heard testimony from a representative of State Armor in support of SB 88. Written testimony was provided by four interested parties. The City Manager of Moraine, Ohio submitted written testimony in opposition to the bill.

An informal hearing for the budget Bill (HB-96) was held in the Senate Government Oversight and Reform Committee. A presentation was given by ODVS Director Debrah Ashenhurst. She informed the

members about how state funds were being used and the need for upgrades and modernization at the two Ohio Veterans Homes and the progress to get it accomplished. She talked about the many other programs the ODVS does for Ohio veterans because of the support of the legislators. When she was finished, she announced to the Committee that the next day would be her last day as Director. She was stepping down so she could enjoy retirement with her husband.

Following the director were presentations by several Veteran Service Organizations. Written testimonies were received from officers of the American Legion and the 37th Division Veterans Association. Giving in person presentations were Michael Stith of the Disabled American Veterans, David Root of the Veterans of Foreign Wars, Don McCauley of American Veterans, and Richard Arthur of the Vietnam Veterans of America.

They each talked about the many things their organizations do and how important the state funding is and how it

enables them to carry out their programs.

On Wednesday morning House Bill 22 had a fourth hearing in the House Ways and Means Committee and there was no testimony offered. The bill introduced by

Representatives **Brian Lorenz** (HD-60) and **David Thomas** (HD-65) would amend sections of the Revised Code to authorize a full homestead exemption for surviving spouses of members of the uniformed services killed in the line of duty.

The Senate Transportation Committee met Wednesday morning and heard testimony first from Representative King. Her bill, House Bill 50, would enact section 5533.106 of the Revised Code to designate a portion of State Route 47 in Darke County as the "PFC John Wayne Richard Memorial Highway." She informed the members that PFC John Wayne

Richard served in the United States Army in South Vietnam during the Vietnam War. He was killed while courageously fighting communist forces after being caught in a deadly ambush on May 21, 1969. King introduced her bill in February and the House passed it in March with a 92 to 0 vote.

Testimony was heard next for Senate Bill 148. The bill was introduced in March by Senator **Jerry C. Cirino** (SD-18) and this was the second hearing for it. The bill would enact section 5534.675 of the Revised Code to designate a portion of State Route 2 in Lake County as the "Specialist Lloyd Andrew Sellers Memorial Highway." The only witness was the son of SP4 Sellers. He talked about the father he never met and his short time on earth. SP4 Sellers began his tour in Vietnam on January 28, 1967. His son was born February 9. Sellers was killed June 19, 1967, at the age of 21. After the testimony the committee members favorably passed the bill out of committee with a 7 to 0 vote.

That same morning HB 22 had its fourth hearing in the House Ways and Means Committee but there was neither written nor in person testimony provided.

The month of May will keep the Senate busy with hearings in multiple committees as they hear from the people of Ohio concerning the budget as it was passed by the House. At some point, Legislative Service Commission will be instructed to draft a substitute bill to incorporate the changes the Senate would like to make in the House-passed version of the bill. The substitute bill will be considered and amended in the Finance Committee and then passed by the full Senate.

Since the House is not likely to concur with the Senate amendments, the bill will probably be sent to a committee of conference. Conference committee meetings usually take place over a period of at least two weeks, after which the conference committee prepares a committee report to submit to the House and Senate.

Once both houses agree to the report of the conference committee, it will be printed and presented to the Governor.

## LEGISLATION INTRODUCED IN APRIL

- HB 228** Introduced on April 7 by Representatives **Josh Williams** (HD-44) and **Elgin Rogers, Jr.** (HD-42).  
The bill would enact section 5534.617 of the Revised Code to designate a portion of I-280 in Lucas County as the "SSG Jack W. Coy Veterans Memorial Highway."  
It was referred to the House Transportation Committee.
- SR 97** Introduced on April 8 by Senator **Casey Weinstein** (SD-28).  
It resolves that the members of the Senate acknowledge the Month of the Military Child in Ohio, April 2025, and urges all citizens to participate in appropriate programs and activities associated with it.  
It was adopted by the Senate the same day.
- HB 234** Introduced on April 15 by Representative **D.J. Sweringen** (HD-89).  
The bill would enact section 5534.607 of the Revised Code to designate a portion of State Route 2 in Ottawa County as the "Cpl. Robert Dockstader Memorial Highway."  
It was referred to the House Transportation Committee.
- SB 179** Introduced on April 23 by Senator **Terry Johnson** (SD-14).  
The bill would amend sections 341.02 and 5901.03 and to enact section 341.43 of the Revised Code to verify the veteran status of imprisoned individuals and individuals facing imprisonment.  
It was referred to the Senate Armed Services, Veterans Affairs and Public Safety.
